- \$75.00 Registration or renewal fee. (Fees are not pro-rated.)
- Sign Contractors must include a valid Master Electrical License or valid Electrical Sign Contractor License.

CONTRACTOR REGISTRATION APPLICATION (Continued)

It shall be unlawful for any person, firm, corporation or business entity in the business of contracting services which require, by State law or local ordinance, a license to perform such services, to, including but not limited to, erect, construct, enlarge, alter, repair, move, improve, remove, convert or demolish any plumbing, electrical, mechanical, irrigation and/or private sewage disposal system in the City of Melissa, unless such person, firm, corporation or business entity is the holder of a valid registration with the City of Melissa. Such person, firm, corporation or business entity shall be herein designated applicant or registrant.

Any work discovered that is performed with a required Licensed Contractor will be identified to prevent reuse and shall be removed. Multiple violations by a registered Contractor will result in suspension of the Contractor Registration, the right to obtain permits to work in the City, and/or may include the issuance of citations and reporting to the State.

SIGN INSTALLATION PERMIT APPLICATION

No sign, other than those exceptions listed in paragraph 3.1010 of Chapter 3, Article 3.1000 (Permissible Signs That Do Not Require the Issuance of a Sign Permit) of Melissa's Code of Ordinances No. 07-35, shall be erected, placed, attached, or secured to the ground, any building, or any structure, until a permit for such sign has been issued by the Building Official. The permit fee shall be set forth in Appendix A, §9.00(a) of the Code of Ordinances.

No person shall install, erect or maintain any sign, except signs for which a permit is not required, or contract for such service, until such person has applied to the Building Official for a license to install, erect and/or maintain signs, and until such license has been approved and issued.

NOTE: You may be required to obtain a sign contractor's license to install, erect, or maintain signs within the City. See paragraph 3.1004(c) of Chapter 3, Article 3.1000, for exceptions to this requirement.
